Beth has a PAYE pension of 5,000 and Case I income of 2,000 for 2018. What credits is she entitled to? Employee (PAYE) Tax Credit 5,000 x 20% = 1,000. Earned Income Tax Credit 2,000 x 20% = 400. As the combined tax credits are 1,400, there is no restriction on the Earned Income Tax Credit.
